DESCRIPTION OF REQUIREMENTS

EN FRANÇAIS :

L'Office des Nations Unies à Genève (ONUG) souhaite recevoir des expressions d'intérêt pour un appel d'offres qu'il a l'intention de lancer pour la mise à disposition de bennes à déchets de 4 à 30 m3 au Palais des Nations à Genève (Suisse) pour une prériode de trois (3) ans, avec la possibilité de deux (2) extensions d'une année chacune pour une durée totale de cinq (5) ans (3+1+1) sous réserve de l'éxécution satisfaisante des prestations effectuées et de la disponibilité des budgets de l'ONUG.

Les déchets seront triés selon la nature des matériaux, ainsi, les bennes permetteront de collecter séparement les déchets suivants :

- Métaux.

- Matériaux d'excavation, admisible en décharge de type A (Ordonnance sur la limitation et l'éliminarion des déchets (OLED) du 4.12.2015)),

- déchets inertes admissible en décharge de type B (au sens OLED du 4.12.2015),

- bois

déchets verts, et

- incinérables.

L'acheminement des déchets se fera directement du site d'entreposage des bennes vers une installation d'élimination des déchets munie d'une autorisation d'exploiter en bonne et due forme.

Le marché sera attribué au soumissionnaire qualifié dont l'offre remplit essentiellement les conditions énoncées dans le cahier des charges et est considérée comme la moins coûteuse pour l'ONUG.

Veuillez noter que cette demande d'expression d'intérêt (EOI) ne constitue pas un appel d'offres. L'ONUG se réserve le droit de modifier ou d'annuler l'appel d'offres à tout moment. Seuls les fournisseurs considérés comme qualifiés par l'ONUG pour fournir ces services seront invités à participer.

La date limite de réception des expressions d'intérêt (soumettant le formulaire de réponse ci-dessous) est fixée au vendredi 15 mai 2020, 17h (heure de Genève). Toutes les réponses seront traitées de manière strictement confidentielle

IN ENGLISH:

The United Nations Office at Geneva (UNOG) wishes to receive Expressions Of Interest (EOI) for an invitation to bid which it will issue shortly for the provision of waste bins (size between at 4 to 30 m3) at the Palais des Nations and its Annexes in Geneva (Switzerland). The resulting contract will be established for an initial period of three (3) years with the possibility of an extension of two (2) additional and consecutive periods of one (1) year maximum each (3+1+1), provided satisfactory performance of the contractor and availability of funding.

The waste will be sorted according to the nature of the materials, so the skips will allow the following waste to be collected separately:

- Metals.

- Excavation materials, eligible for type A landfill (Ordinance on the limitation and elimination of waste (OLED) of 4.12.2015)),

- inert waste eligible for type B landfill (in the OLED sense of 4.12.2015),

- wood

- green waste, and

- incinerable.

Waste will be transported directly from the skips storage site to a waste disposal facility with a proper operating license.

The contract will be awarded to the qualified bidder whose offer essentially meets all the conditions set out in the terms of reference and is considered the least costly for UNOG

This request for expression of interest is not an invitation to bid. UNOG reserves the right to modify or

cancel this invitation to bid at any time. Only vendors considered as qualified by UNOG to supply such services will be invited to participate.

The deadline for the submitting your response (using the response form attached below) to this EOI is Friday 15 May 2020, at 5pm (Geneva time). All responses will be treated in strict confidence.

EN FRANÇAIS :

L'Entreprise devra se conformer aux lois et règlements en vigueur en Suisse (Canton de Genève), et en particulier à l'Ordonnance sur la limitation et l'élimination des déchets (OLED) et respecter la norme 5 à minima, la norme 6 étant bien évidement à priviligier pour tous les camions à moteur thermique entrant sur site.

IN ENGLISH:

The Company must comply with the local laws and regulations in Switzerland (Canton of Geneva), and in particular with the Ordinance on the limitation and elimination of waste (OLED) and comply with standard 5 as a minimum, standard 6 is obviously to be preferred for all trucks with internal combustion engines entering the site.
