DESCRIPTION OF REQUIREMENTS

EN FRANÇAIS:

L'Office des Nations Unies à Genève (ONUG) souhaite recevoir des expressions d'intérêt pour un appel d'offres qu'il a l'intention de lancer pour la fourniture de services de logistique et de manutention au Palais des Nations de l'ONUG et ses annexes à Genève (Suisse). Suite à cet appel d'offres un contrat sera établi pour une durée initiale de trois (3) ans avec possibilité d'une prolongation de deux (2) périodes supplémentaires et consécutives d'une (1) année maximum chacune (3+1+1), sous réserve de l'éxécution satisfaisante des prestations effectuées et de la disponibilité des budgets de l'ONUG.

Cette prestation de service clés en main comprend :

- le déménagement de mobilier de bureau, d'armoire forte et/ou de coffre-fort ;
- le déménagement de caisses de documents des fonctionnaires ;
- le transport de PC et d'écrans, le transport de palettes de documents et d'archives ;
- le transport à la destruction de documents confidentiels ;
- le démontage et montage de mobilier de bureau, le rangement des stocks de mobilier ;
- le tri et l'évacuation du mobilier obsolète ;

• la fourniture des équipements de protection individuelle du personnel de manutention, des moyens et équipements techniques, des outils et des véhicules de déménagement avec chauffeur.

Le marché sera attribué au soumissionnaire qualifié dont l'offre remplit essentiellement les conditions énoncées dans le cahier des charges et est considérée comme la moins coûteuse pour l'ONUG.

Veuillez noter que cette demande d'expression d'intérêt (EOI) ne constitue pas un appel d'offres. L'ONUG se réserve le droit de modifier ou d'annuler l'appel d'offres à tout moment. Seuls les fournisseurs considérés comme qualifiés par l'ONUG pour fournir ces services seront invités à participer.

IN ENGLISH:

The United Nations Office at Geneva (UNOG) seeks expressions of interest for an invitation to bid which it will issue shortly for the provision of logistics and handling services at the Palais des Nations and its annexes in Geneva (Switzerland). The resulting contract will be established for an initial period of three (3) years with the possibility of an extension of two (2) additional and consecutive periods of one (1) year maximum each (3+1+1), provided satisfactory performance of the contractor and availability of funding.

These turnkey services include:

- moving office furniture, strong cupboard and / or safe;
- moving boxes of UNOG staff's documents;
- transport of PCs and screens, transport of pallets of documents and archives;
- transport to destruction of confidential documents;
- disassembly and assembly of office furniture, storage of furniture stocks;
- sorting and removal of obsolete furniture;

• the supply of personal protective equipment for handling personnel, technical means and equipment, tools and moving vehicles with driver.

The contract will be awarded to the qualified bidder whose offer essentially meets all the conditions set out in the terms of reference and is considered the least costly for UNOG

This request for expression of interest is not an invitation to bid. UNOG reserves the right to modify or cancel this invitation to bid at any time. Only vendors considered as qualified by UNOG to supply such services will be invited to participate.

The deadline for the submitting your response (using the response form attached below) to this EOI is Friday 22 May 2020, at 6pm (Geneva time). All responses will be treated in strict confidence.

EN FRANÇAIS:

1- L'ensemble des services devra être réalisé suivant les normes et réglementations cantonales et fédérales du pays hôte en vigueur (Suisse).

2- L'adjudicataire du contrat devra être en capacité de mobiliser, simultanément, sur le site de l'ONUG, vingt (20) manutentionnaires qualifiés dans les travaux de logistique, de manutention et de déménagement ainsi que l'encadrement correspondant.

3- L'équipe d'encadrement devra obligatoirement communiquer à l'oral et à l'écrit en langue française, et être capable de communiquer en anglais si besoin.

IN ENGLISH:

1- The services must be carried out in accordance with the applicable cantonal and federal standards and regulations of the host country (Switzerland).
